Students of **B.Tech II semester** course are hereby informed that the dates of remittance of semester fee are as follows :

Date of commencement of class : 24.01.2019

Remittance of fee starts from : 28.01.2019

- The date of remittance of fee without fine : **From 28.01.2019 to 03.02.2019**
- The date of remittance of fee with a fine of ₹ 70/- (Rupees seventy only) : **From 04.02.2019 to 13.02.2019**
- The date of remittance of fee with a fine of ₹ 615/- (Rupees Six hundred and fifteen only) : **From 14.02.2019 to 05.03.2019**
- Defaulters after **05.03.2019** should remit ₹ 1220/- (Rupees One thousand two hundred and twenty only) towards readmission fee in addition to the late fee of ₹ 615/- (Rupees Six hundred and fifteen only) and will not be eligible for attendance till the date of remittance of fee.

All the students including those who are availing Educational loan should remit their fees through "SBI collect" only, provided in "www.onlinesbi.com". They can also remit their fee by cash at any S.B.I branch by chalan generated through above Online system.

If the students are using the way of challan generation for fee payment they should remit the amount to the bank on the same date itself.

Students can use UPI facility(BHIM APP) of the payment option in the new version of SB collect so as to reduce the service charges.
