### ORDER

The University has revised the fee structure by effecting 5% hike in the student related fee for 2023 Admission onwards vide the U.O. read as (2) above. Vide paper read as (1) above, it has been informed that in Appendix IX - Fee for Ph.D Programme - (I) - Fee to be collected from the Research scholars at the time of Admission,

- 1) Sl. No. 6 - University Union Fee - had been wrongly given as 300 instead of 400.
- 2) Sl. No. 10 - Sports Fee - had been wrongly given as 370 instead of 500.
- 3) Sl. No. 12 - Arts fee - had been wrongly given as 300 instead of 400.

and has requested to make necessary corrections.

In the Appendix III - Fee Structure - 4 Year B.Tech Marine Engineering -

- 1) In the Table I - " University Fee" (at the time of admission) had been wrongly given as "University Union Fee" (at the time of admission).
- 2) Sl. No. 5) - Payment of fees - "First semester fee is to be paid at the time of admission" had been wrongly given as "First and second semester fees are required to be paid at the time of admission".

Considering the above, the Vice Chancellor has accorded sanction to correct the U.O read as (2) above as follows:

1) Appendix IX - Fee for Ph.D Programme - (I) - Fee to be collected from the Research scholars at the time of Admission - Sl. No. 6 - University Union Fee as 400; Sl.No. 10 - Sports Fee as 500 and Sl. No. 12 - Arts fee as 400.

2) Appendix III - Fee Structure - 4 Year B.Tech Marine Engineering - In the Table I - "University Union Fee" (at the time of admission) is corrected as " University Fee" (at the time of admission). Similarly in Sl. No. 5) - Payment of fees - "First and second semester fees are required to be paid at the time of admission" is corrected as "First semester fee is to be paid at the time of admission".
