## **ORDER**

The University had revised the fee structure by effecting 5% hike in the student related fee for 2024 Admission onwards vide the U.O. read as (7) above. The following are, suggestions/clarifications/additions are sought in this regard.

- 1. The Directorate of Admissions, vide paper read as (1) above has intimated the following.
  - The NRI fee for the programme 5 year Integrated M.Sc Photonics is not included in the fee revision 2024.
  - All India Quota (AIQ) fee for 5 Year Integrated M.Sc programmes (Photonics / Computer Science / Physics / Chemistry / Mathematics / Statistics / Biological Science) are included in the fee Revision Order 2024 even though they are listed under UG programmes in the Prospectus 2024, where AIQ is not applicable.
- 2. The Director, ICREP, CUSAT vide the paper read as (2) above requested to include the Library fee (₹1290/-), Lab fee (₹2000/-) and seminar fee (₹250/-) for the programme B.Sc Computer Science LLB in the fee revision order 2024.
- 3. Inclusion of tuition fee ₹10,000/- per semester of the newly started programmes, PG Diploma in Academic Writing, in the Department of English and Foreign Languages, sanctioned vide paper read as (3) above to fee revision order (paper 7).
- 4. Inclusion of one-time fee of ₹500/- for Campus Radio permitted vide paper read as (4) above, to be collected from the students and research scholars from 2024 admission onwards, in the fee revision order 2024 (paper 7).
- 5. Clarification requested from DoA on NRI and AIQ fee of MBA Executive programme.
- 6. Clarification on the AIQ fee, for 3-year LLB programme, is sought by DoA intimating that the programme's seat allotment is in AIQ matrice.

7. The Director, KMSME, vide paper read as (6) above, has requested to enhance the PTA fee of B.Tech Marine Engineering programme to ₹4000/- and to implement a Placement and <u>Training fee of ₹500/- per semester</u>, from the Academic year 2024 onwards.

Considering the above, sanction has been accorded the Vice Chancellor to modify the fee revision order 2024, paper read (7) as indicated below, subject to the ratification of the Syndicate.

- a. To include NRI tuition fee of ₹66,570/- for the Programme 5 Year Integrated M.Sc in Photonics.
- b. To include the Lab fee (₹2000/-), Library fee (₹1290/-) and Seminar fees (₹250/-) for B.Sc Computer Science LLB Programme.
- C. To include tuition fee of ₹10,000/- (per semester) for the newly started programme PG Diploma in Academic Writing.
- d. Inclusion of **one-time fee of ₹500/- for Campus Radio**, sanctioned vide paper read (4) to the list of common fee in the paper read (7) which is to be collected at the time of admission from the students and also from research scholars.
- e. MBA executive programme is to be considered as cost sharing and to include NRI tuition fee for the same ₹80,000/- and AIQ tuition fee ₹50,000/-
- f. To include AIQ tuition fee for the 3 Year LLB programme as ₹46,200/-.
- g. To enhance and unify the PTA fee of SoE, CUCEK and KMSME to ₹4000/-and also to implement a Placement and Training fee of ₹500/- per semester, for <u>B.Tech Marine</u> Engineering programme w.e.f the 2024 admission onwards.
- h. It is also clarified there no AIQ fees is applicable to 5-year Integrated M.Sc programmes as said programmes are listed under UG programmes and have no AIQ category.

The U.O. read as paper (7) above stands modified to this extent.
